

2. Copies of any third-party audit reports you are willing to share.

In 2022 we had a labor audit (link ¹⁰ attached), in which occupational and industrial safety regulations were verified. As a result, we were issued with an Occupational Safety License, from which I would like to translate certain relevant extracts for your information:

"(...) Occupational Health and Safety currently represents one of the most important management tools to improve the quality of working life in companies and therefore their competitiveness. This is possible as long as the company promotes and encourages at all times the creation of a culture of occupational health and safety that must be synchronized with quality plans, improvement of processes and jobs, productivity, development of human talent and the reduction of operational costs.

Therefore, Agropecuaria Puerta del Cielo, Sociedad Anónima, has among its objectives the development of the Occupational Health and Safety Plan -SSO- in order to improve the quality of working life, achieve a reduction in costs generated by accidents and occupational diseases, improve the quality of services and, above all, generate healthy environments for workers.

Agropecuaria Puerta del Cielo, Sociedad Anónima, as an entity responsible for Guatemalan laws and labor rights and respect for life and health, presents this Occupational Health and Safety Plan.

The Occupational Health and Safety Plan (OHS) is aimed at achieving adequate risk management that allows for permanent control of the risks in the different trades and that contributes to the physical, mental and social well-being of the worker and to the operation of the resources and facilities.

The document presented below reflects the Occupational Health and Safety Plan -SSO-, for the company based on the specific characteristics of its process and its economic activity." (sic)

This allowed us to obtain an Occupational Safety License, duly issued by the Ministry of Labor and Social Security of Guatemala, as can be seen in the development of the Occupational Safety Plan ¹¹ and also on their website ¹². *Note: In this Plan still appears the previous PDC logo.*

<u>3. HACCP plan – including hazard analysis and controls;</u> <u>critical control points with critical limits.</u>

Since we do not yet process lemongrass, but only offer it as raw material at the moment, according to our advisor's criteria, HACCP certification would not apply to us and, therefore, we would not need hazard controls, critical control points or control with critical limits.

In this regard, the previously described license (the occupational safety license) covers certain points regarding hazard controls and critical control points. This license (HACCP) has never been previously required from us, and if requested by you, we could obtain it later.

It is worth mentioning that, for the safety and control of the client and the final consumers, every exported shipment is subjected to laboratory tests by the company Soluciones Analíticas, S.A.. ¹³, of which I would like to present some as an example, through the links that will appear at the bottom of this document. ^{14 15}

The previous statement does not imply that we have not yet foreseen and defined the processes involved in crushing and micro-crushing lemongrass, as well as turning it into essential oil, which would represent the following steps for our business on a medium term so we could accompany the growth of this global market.

4. Table of contents of the food quality/safety manual.

Along the same lines, since we do not yet process lemongrass as a finished product (production, packaging, distribution and storage of ready-to-eat product), but only offer it as raw material for the moment, according to our advisor's criteria, it would not be necessary for us to prepare a food quality/safety manual.

Therefore, this Manual (HACCP) had never been previously requested from us, which, if requested by you, we could eventually provide.

5. Copies of the following Standard Operating Processes:

• Traceability.

TRACEABILITY PROCESS OF RAW MATERIAL PREPARATION:

- 1. **Objective:** Ensure a methodology that guarantees traceability during every stage of the production process until the finished product is shipped to customers.
- 2. **Responsible parties:** Those responsible for implementing the product traceability procedure are: The Farm Manager and the Farm Workers.
- 3. Traceability flowchart description:
 - a. Land preparation:

Land preparation is carried out in phases according to the annual plantation rotation plan.

b. Sowing:

New clumps are planted from the same plants in the previously prepared soil.

c. Weed clearing:

Weeds are cleared manually as they grow.

d. Cutting the fresh leaf:

The perimeter section of the raw material that is ready to be cut is programmed.

e. Sun drying procedure:

The green leaf is placed on tarps in the drying yard to be dried in the sun for 2 or 3 days as appropriate.

f. Baling:

Once the green leaf is dry, it is moved to the storage warehouse, where the baling process is carried out, using specific baling machinery.

g. Packing:

The previously wrapped bales are received to be placed in specific sacks according to the size of each one. The edges are embroidered to seal the bales, and a number is assigned to every single one for inventory rotation.

h. Storage:

Once the bales are packed, they are stacked on top of each other to form rows to be collected on the farm.

i. Loading of merchandise into containers, dispatch of raw materials:

Once the sale is made, the merchandise is delivered to be loaded onto the transport to be taken to its final destination. The person in charge will fill out the output record of the production sent.

j. Monitoring and logs:

We work along the shipping company responsible for transporting the product.

• Employee training in food safety:

To meet this requirement, it is necessary to obtain a certificate of food handling training for every employee, and must be issued by the Ministry of Public Health and Social Assistance ¹⁶ (MSPAS), specifically its headquarters in Retalhuleu. This entity is equivalent to the FDA in Guatemala. In the link of this paragraph, you will find the health cards for each of the seasonal workers on the farm.

• Allergen control:

 According to our advisor, regarding allergen control in food safety ¹⁷, our product is not classified among the common raw materials in which certain allergens for human consumption are usually triggered (exemplified in the following picture), so we do not currently carry out this control. However, if you require it, we could prepare in the future.



Similarly, since these are not meats, according to our advisor, we would not have to apply for a Kosher License.

• Sampling protocols:

Sampling plan is defined as the process determined for the selection, extraction, preservation, transportation and preparation of the portions to be taken from a population to serve as samples.

Currently, the samples to be analyzed are randomly chosen from the last cut from the production to be exported. This sample is sent from the farm to the headquarters in the city for proper preparation. It is hermetically packed in a sterile bag for laboratory analysis. The laboratory that we work with, as we have already mentioned in the document, is Soluciones Analíticas, S.A.¹⁸

If you consider that we should implement a more formal protocol for sampling, we could over time and also, if you would like to perform laboratory analysis at a place of your choice, we would be happy to send you the samples to be performed.

• Pest control:

Dried lemongrass leaf itself is a natural repellent. However, since it is an organic plantation, it does indeed have insects living within the plantation as their natural ecosystem. But, when the product is dried in the sun, it loses certain characteristics that cause live insects to return to the live grass clumps. It is the natural cycle that has allowed us to have a healthy, beautiful plantation with a unique scent.

It is worth mentioning that, in the place, there are no rodents, cats or dogs that could contaminate the plantation or the stored raw material. However, we help ourselves with the company "PCT Control de Plagas", from whom I send you a link with the reports of the services¹⁹ carried out during this year, as an example, regarding the rodent control that we preventively carry out in the warehouse and in the office of its manager.

As expected, there have been no incidents with rodents during all these years, but we know the importance of maintaining this preventive service. However, if you require integrated control with other pests, we could implement it immediately.

• Providers Approval Program:

There is no Providers Approval Program since they are directly hired, and because of the long lasting marketing agreement between the parties, it is not currently thought necessary. If you thinks it is adequate, we can prepare it afterwards. Also, if you would like to have the details on every one of our current providers, we can gladly share them with you.

This species is known in Cuba with the common names of Caña Santa, Cañita de Limon, Grass of Fever and Lemon grass (Roig, 1974);

Zacate Limon, Lemon Tea and Zacate Tea in Costa Rica, Honduras and Guatemala.

As well as Lemongrass in Venezuela and the Dominican Republic (Germosen Robineau et al., 1996).



Its reproduction is agamic, because its propagation is carried out by portions of the mother plant, which are known as offshoots or children, obtained by division of the clump. Up to 50 new plants can be obtained from an adult mother plant. There is another type of vegetative materials that reproduce by means of seeds. The greatest height of the plants is obtained with high densities, 22,200 plants per hectare. The grass is cut 3 to 4 times a year, with intervals of 70 to 75 days between cuts during the harvest year.





7. Finished product specifications, including country of origin, packaging, and shelf life.

The finished product is the raw material described above, which is packed in white bales that, filled with the product, can reach in average a width of 21.65 inches, a thickness of 15.35 inches and a height of 36.61 inches. This allows us to fit a total of 400 bales in a 40-feet container. However, if the client would like to use other measurements, we can adapt to them.

The product is non-perishable because it is organic. However, it begins to lose its aroma, color, and properties approximately one year after being properly packaged, according to the experience we have gained over the years and some analyses we have conducted through APAESA ²⁰, the entity where we have carried out the relevant tests.

We offer the product in dried leaf form, crushed, micro-crushed, and as essential oil. These various presentations of our product are made to order, as this product is currently undergoing favorable tests for processing and distribution.

It is important to mention that the entity currently operates under the EXW (Ex Works) Incoterm, meaning it will be ready for delivery at the entity's facilities. However, once we have details about potential buying clients, we can work on a FOB and CIF basis, adding the respective costs.








