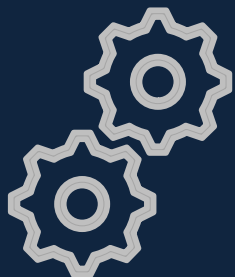

- We work with procedures based on compliance for the management and operation of projects.

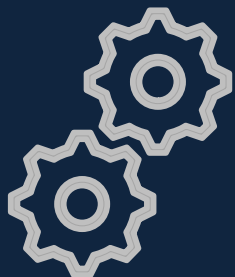

- We have professional compensation insurance, which may cover the payment of fines.

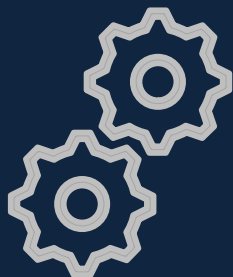
