Brazilian Facts

- The Federative Republic of Brazil is Latin America's largest economy. With 3,290,000 square miles, bordering 10 other countries and with 4,650 miles of coastline, Brazil is the largest country in Latin America and fifth largest in the world. Brazil's 2015 Gross Domestic Product (GDP) of US\$2.2 trillion ranks Brazil as the world's eighth-largest economy;
- Brazil is Latin America's largest country, and the ninth largest economy in the world. According to the United Nations Conference on Trade and Development (UNCTAD), Brazil was the eighth largest destination for global Foreign Direct Investment (FDI) flows in 2015. Brazil typically receives close to half of South America's total incoming FDI;
- Brazil has 13 cities with over one million residents and its most important cities are São Paulo, Rio de Janeiro, Salvador;

São Paulo Facts

- São Paulo is both the name of a state, as well as, a city. This state has 645 municipalities and a population of approximately 40 million inhabitants. According to IBGE, Brazil's main government research institute, the population in the city of São Paulo is about 11 million inhabitants. If we take into account the metropolitan area, which includes 38 smaller cities around the capital, the population is almost 19,000,000 inhabitants.
- São Paulo is, by far, the most important industrial State of Brazil. The region that surround São Paulo city, which includes the cities of Santo André, São Bernardo, São Caetano, Diadema (known as ABCD), Guarulhos, Osasco, Suzano and others (collectively known as Grande São Paulo) concentrates the largest and most diversified industrial park of the country.


