# TRADE MARKS

#### URGENT CASES:

- 1. Name of applicant.
- 2. Details of mark.
- 3. List of goods and/or services.
- 4. Dates, application numbers, applicant, and countries of any convention priorities claimed.

# **FULL REQUIREMENTS:**

- 1. Name, address, nationality of applicant and ID.
- 2. Power of Attorney, Notarial certification and Apostille Seal or Consular Legalization required.
- 3. Details of the mark and whether is in use in Argentina.
- 4. List of the goods and/or services.
- 5. Date and country of any convention priority.
- 6. Civil status. In case of being a case the full name of the spouse.

#### **GENERAL INFORMATION**

### APPLICANT

The proprietor of the mark, individual or corporation; two or more parties can apply jointly.

#### CLASSIFICATION

International 45 classes of goods and services. Multiple class applications are not admissible, applicant must file an application to cover each class.

### **EXAMINATION**

Automatic, timing is dependent on official workload (Typically 12-14 months). Expedited examination is not possible. If a conflict has emerged Judge must wait for official decision.

### ACCEPTANCE AND REGISTRATION

After acceptance by the Trade Marks Office a final fee is payable, to obtain the trademark certification.

# **PUBLICATION**

The trademark is published after a formal exam by Trade Marks Office (typically 3 months).

### OPPOSITION

Opposition is possible if a notice of opposition is filed within 30 days from the publication date.

Marks are subject to revocation if not used for continuous periods of five years since the date of registration.

### MARKING

Not compulsory.

The initial term is 10 years renewable indefinitely for periods of 10 years.

# REGISTERED USER

A licensee or licensees may be recorded as registered user(s). Such record is not compulsory however licensee benefits from such record with tax exception and legal oppositions to third parties.

### **ASSIGNMENTS**

Assignments may be with or without goodwill and now the assignment can be recorded whilst the application is still pending.

#### PCT NATIONAL PHASE ENTRY

Not available. Argentina has not signed this treaty.

### **GENERAL INFORMATION**

### **APPLICANT**

Inventor or assignee; individual, or corporation; two or more parties can apply jointly

#### **NOVELTY**

Absolute worldwide novelty (non disclosure). A one and a half year grace period applies for Paris Convention disclosures. Priority certificate must be filed.

### **EXAMINATION**

Formal Exam: within 90 days of date of filing.

Main Exam: within 18 months from Formal Exam. Request is

required. An examination fee is payable.

Examination may be expedited. Examination is for Inventive Activity, Novelty and Industrial Application.

# **EXAMINATION/CERTIFICATION**

A granted Patent is only enforceable after it is certified. A request for examination may be filed at any time during the term of the Patent. After successful prosecution of the examination the Patent is certified, and then is enforceable.

## **TERM**

20 years from filing

# **ANNUITIES**

Maintenance fees are payable for the third and subsequent year, in advance. Fines for late payments are applicable.

- 2. Copies of each view of the design (may be drawings or photographs).
- 3. Date, applicants and country for any convention priority claimed.
- 4. Convention priority documents (and certified English translation).
- 5. Civil status. In case of being a case the full name of the spouse.

## **GENERAL INFORMATION**

### APPLICANT

Author or assignee; individual or a corporation; two or more parties can apply jointly.

## **NOVELTY**

Absolute; that is publication anywhere, use in other countries before filing.

#### REGISTRATION

Formality examination is automatic and registration is without substantive examination. A granted Industrial Design is enforceable against third parties.

# CERTIFICATION

A Registered Design is only enforceable after it is certified. After successful prosecution of the examination a Certificate of Examination issues and the registration is then enforceable.

#### **PROTECTION**

The protection relates only to the ornamentation of the article and not to the functional features of the design.

## MARKING

Not compulsory

#### TERM

Fifteen (15) years from filing date subject to renewal every 5 year period.
