- Elaboration and filing of the annual income tax return for those expats obligated to file annual tax return in Mexico.
- Application to obtain the Mexican tax residency certificate, for those expat employee subject to prove Mexican tax residency in their home countries.
- Filing of the repatriation notices for those expat employees who have concluded with their Mexican assignment.
